I state that:

1. I am presently employed by IBM Australia Ltd (**IBM**) as a Partner and AIS Delivery Leader for the Growth Market Unit of IBM GBS. At the time of the Queensland Health Payroll project I was the Delivery Excellence Leader, responsible for the health and profitability of the IBM Australia and New Zealand GBS project portfolio.
2. In the course of my duties, I have access to business records that are created and kept in the ordinary course of IBM's business.
3. I have been shown a list of sub-contractors engaged by IBM under the Contract dated 5 December 2007 between IBM and the State of Queensland (Exhibit 128) (the **List of Subcontractors**). I have been told by Ashurst that the list was disclosed to the Commission by Ashurst on behalf of IBM on 27 February 2013. The reference on it to 'Corptech List of Subcontractors' is a reference to the IBM subcontractors engaged on the Shared Services Project, pursuant to the contract being managed by CorpTech.
4. The list identified ThinkStorm and Infor both of which are specialist WorkBrain subcontractors providing specialist Workbrain expertise. We had Infor personnel in functional and technical roles on the Project, as well as both Infor and Thinkstorm technical resources fulfilling roles such as functional and technical consulting, coding, and configuration.
5. The List of Subcontractors shows, among other things, the engagement of a number of ThinkStorm and Infor sub-contractors during 2008, 2009 and 2010. I have caused a search to be undertaken of IBM's internal records to find further documents which set out, in further detail, the engagement of ThinkStorm and Infor sub-contractors during the Shared Services Project. As a result, a spreadsheet has been located on IBM's system which is attached to this statement. I have been informed by Rachael Franklin, a GBS Contract Financial Specialist, and believe that this spreadsheet was generated during the course of the Shared Services Project. The spreadsheet shows the hours spent per day in each month by Infor and ThinkStorm contractors. It shows that these contractors largely worked full days.

6. In the table below, I have summarised the contents of the attached spreadsheet as they relate to the engagement of Infor and ThinkStorm contractors under Statements of Work 5, 8 and 12 between January 2008 and March 2010.


